4.3	Bins. LBH won't act unless there is a health & safety problem. Agreed to continue	ВВ
4.4	pressure. BB to follow up. Towpath to Cow Bridge: vegetation has been savagely cleared. Tim to investigate [done, see blogspot.millfieldsusers].	TE
4.5	Dog shit. Bruce Irving is looking for sources of free poo bags.	
4.6	Playground women's toilets broken hinge. Bruce Irving has put on LBH repairs list. No deadline so no point our waiting. Decided Claire will get it fixed and MUG will pay. Ditto lock on men's toilet.	CK
4.7 4.8	Depot robbery. Insurance will cover – eventually. Cafe at playground. LBH refuses to let MUG start one, insists on procurement process. But not yet, because procurement procedure is about to be rewritten and then LBH will review park cafes. Since noticeboards review started 3 years ago and has yet to result in action, derision was expressed. Decided IR to press McShane on cafe as voluntary project.	IR

- 4.9 Shared use path under bridge: British Waterways is moving railing outwards to achieve widening & is thinking about sightline etc.
- Master plan. Bruce Irving still awaiting revised plan. Concluded plan is dead in the water 4.10 & we should press ahead with our priorities, starting with cafe as above.

5 National Grid Access Route Consultation

NG has held 2 meetings, with IR and with Hillstowe St residents. No decision yet. EDF temporarily closing route 4 for repairs in Jan. NG+EDF looking at using rte 4 for heavy vehicles, though restricted width will prevent its use for the widest loads. Martin Kinsey (NG project manager) is working on access via east side of EDF site.

NG not interested in paying for park hub but do want to pay for landscaping. Currently consulting Paul Foinette. We should bear in mind the possibility of funding for biodiversity and for community involvement.

The next major works at Millfields will start in late 2013 & comprise building of the head house for the tunnel from Haringey now under construction.
